- Adheres to client service standards, documentation standards, guidelines, and related policies and procedures as established at RCC.
- Serves as a resource to staff and outside agencies concerning clinical issues and intervention techniques.
- Contributes to the delivery of quality SLP services by examining, developing, refining, and evaluating the specialty body of knowledge and care practices.
