**Responsibilities:**

The Rehabilitation Centre for Children is a community-based health care facility providing services to children with special needs and their families.

The Rehabilitation Centre for Children requires a speech-language pathologist to lead Blooming Words implementation and support resource development, knowledge translation, and evidence informed practices in collaboration with Children’s Therapy Network of Manitoba (CTNM) partners.

The speech-language pathologist requires advanced skills and knowledge and performs at a high level of independence as a clinical leader, consultant and educator. Services are in accordance with RCC policy and professional standards. This includes:

- Collaboration with school, healthcare, childcare and community agencies
- Ongoing liaison with CTNM partners
- Ongoing program evaluation and outcome measurement

- Minimum of five years clinical experience in pre-school and school aged populations *required*
- Minimum three years experience with virtual, hybrid and in-person group facilitation *preferred*

- Previous experience with provincial projects, evaluation and reporting
- Previous experience in resource development
- Experience using and supporting proprietary software
- Understanding of change management principles and strategies
